Except for the above, Robert Wojdyna has not been within the past five years and he is not at present a member of administrative, managing or supervisory organs in commercial companies or partnerships.

According to a submitted statement, Robert Wojdyna does not run any other based business activity except for the Issuer's one, which is of significant importance to the Issuer, except for (i) being a Partner in Budo-Market R. Wojdyna, M. Skwarski, J. Wojdyna Sp. j in Marki, which deals with selling building materials, including construction steel; the company makes purchases from the Issuer and the Issuer occasionally makes purchases from the company; the company is managed by an external entity on the basis of an agreement for management. Robert Wojdyna does not run any activity competitive to the Issuer except for being a Partner in the company Polcynk Sp. z o.o. which deals with the production of steel constructions and covering metal surfaces with zinc; Polcynk Sp. z o.o. purchases steel from the Issuer and the Issuer purchases services from Polcynk Sp. z o.o.

According to the submitted statement, within the past five years Robert Wojdyna:

- has not been punished for fraud;
- has not been a member of administrative, managing, supervisory organs or managing organs of a higher level in entities which have declared bankruptcy or have been in the state of liquidation or into which compulsory administration has been introduced;
- has not been subject to formal public accusations or sanctions by legislative or regulatory organs (including labour unions);
- has not received an injunction which would ban him acting as a member of administrative, managing or supervisory organs of any Issuer or participating in managing or conducting issues of any issuer.
